Rationale for modification proposal

The purpose of this modification is to introduce to the Code a common template for DNOs to use to meet their obligations to publish an annual report by the end of September each year to demonstrate their compliance with the CiC Code of Practice.

The template contains criteria that each DNO must report against and the format of the information to be provided.

A common template will allow stakeholders to more easily identify how DNOs comply and be able to compare approaches. Greater visibility will help to not to restrict, prevent or distort competition in the electricity distribution connections market.

Proposed Solution and Draft Legal Text

Please indicate the proposed change to the text as is current in the CiC Code of Practice. This is to provide an indication of the proposed changes to the text and can be refined as part of the working group process.

9. Reporting Requirements

- 9.1. Each DNO shall publish an annual report by the end of September each year to demonstrate their compliance with this code of practice. This report shall include reporting on the volume of inspections by the DNO on connections completed by all parties (including the DNO's own business or affiliates and competitors).
- 9.2. The report will include such detail on processes and procedures and available metrics to demonstrate the DNO is providing the equivalent level of service to independents as to them undertaking connection activities themselves for each of the Input Services. <u>A common template for reporting is included as Appendix 2.</u>
- 9.3. The detail of the reporting requirements will be developed in conjunction with stakeholders and approved by Ofgem. These details shall be finalised by 15 January 2016 and if appropriate a modification raised. If a modification is not deemed appropriate the DNO shall, in co-operation with the other DNOs, provide an explanation to Ofgem.
